OBJECTIVE

- **Provide support to small enterprises in the start-up phase from the moment of conception of the business idea to the company's first two years of life.**
- **Prioritising those operating in the sectors: ICT, micro-electronics, bio-medical, energy and the environment, services for the wooden furniture and furnishings division.**





THE STRUCTURE

- **GROUND AREA:** 600 sq. m.
- **MODULES:** 10 office premises (25\35 sq. m.)
- **COMMUNAL AREAS:** office, meeting room, auditorium, guest quarters
- **EQUIPMENT:** cabled and furnished structure provided with hardware, telephonic, internet, intranet connections

- ***Tendency for development of elements of complementarity and propensity for the products' qualification***



- **FORM:** www.polotecnologico.it
- **DEADLINE:** before the 30th day of each month



THE PRE-INCUBATION

- **Selection and valuation phase of the business ideas by a staff comprised of Polo personnel, experts from the university world and consultants who work in close daily contact with the market and enterprises**
- **The duration may vary in relation to the abilities and expertise of the individual enterprises**
- **Made up of a formative informative on the business-plan and of direct and specific consulting on the individual b\p**



START OF THE INCUBATOR

- Last July the incubator was inaugurated at Polo Tecnologico of Navacchio and the experiment was launched
- There are already 5 companies operating in the incubator and two in pre-incubation
